5 To Receive the Chairman's Annual Report

The Chairman said the report had been circulated with the AGM papers and asked for it to be adopted. Proposed by Mrs Doreen Teale and Seconded by Mrs Fiona Stephens. Agreed.

6 To Receive and Adopt the Audited Accounts for the year ended 31 March 2019

The Treasurer, Mr Don Richardson, introduced the account for the year ending 31 March 2019 which had been audited and certified by Mr Colin Goddard. He explained that the operating surplus of £1,726.16 was mainly from unbudgeted income and deferred costs and after due consideration a decision had been taken to increase the membership subscription from £37 to £39. There had been no increase the previous year. The breakdown of the subscription was £13 Lecture Fees, £4 Hall costs and £16 Affiliation Fees and Area fees. Therefore £33 was fixed, and £6 to run our organisation seems not unreasonable. The general reserve balance provided us with a cushion of 9 months operating costs. There being no questions submitted he asked for the accounts to be adopted. Proposed by Mr Tony Jones and seconded by Dr John Evans. Agreed.

7 To Re-appoint Mr Colin Goddard as Financial Examiner for the ensuing year.

Mr Colin Goddard had agreed again to be the financial examiner for the coming year. Proposed by Mr Hugh Hazlehurst and Seconded by Mrs Willa Hislop. Agreed.

CHAIR'S REPORT - NOVEMBER 2020

I think it is safe to say that the past year and a half has been like no other as we started off in the usual way and ended up in a completely different world. The Coronavirus pandemic has impacted on all of our lives. I would like to extend the Society's thanks to the small committee team, our President Heather Normand and our Webmaster for their tremendous efforts to keep the Society active and welcoming in very difficult circumstances. The learning curve was very steep for all of us and the time and effort needed to cope with the ever changing landscape and uncertainty was considerable. The Arts Society is to be commended for the speed in which they set up the "Connected" website to keep us all in touch with each other and the arts.

Honorary Treasurer: Don Richardson has managed our financial situation with accuracy and professionalism whilst dealing with all the changes to our income and expenditure over the past few months. As your membership was extended to the end of this year he is proposing to take this opportunity to change our financial year to a calendar one beginning in January 2021, and a special resolution is being put forward for you to vote on at this AGM. This will bring our accounting period in line with other Societies.

Honorary Secretary: Edie Desmond has provided us with an excellent service. She has provided us with a schedule of work and makes sure, in the nicest possible way, that we all meet our deadlines. She works with care and precision and the support she has provided to me and to the team is invaluable.

Programme: Carolyne Hazlehurst has presided over a year with two parts. We had five lectures 'in person', including the very entertaining Rupert Toovey on the wonderful artists of Sussex; his reflection on "poor St Ives" amused us. There was an outstanding lecture from Bertie Pearce where we learnt about Charles Dickens' life and his characters delivered with great drama and panache. Word went out and we had an upsurge in applications for membership of the Society. Then came lockdown! It took some time for a new way of working to be tried and tested but in July we had our first Zoom lecture with Peter Medhurst. This was a treat as he was able to play to us from his own music room on various historic keyboards. Carolyne has spent an inordinate amount of time since re-organising our current programme and booking speakers for 2021 ensuring that they are able to deliver in person or via Zoom. The quality and variety of talks is still as high as ever and the incredibly competent and knowledgeable lecturers of The Arts Society are to be commended for their willingness to develop new working practices so quickly. We have a very exciting programme for you in 2021.

Visits: Miek Bell took a coach party to Windsor Castle in December 2019 when all the staterooms were open and the Christmas decorations were up. It was a marvellous trip which everyone thoroughly enjoyed. Following lockdown she was faced with the unenviable task of dealing with the effects of the coronavirus on venues when the uncertainty factor meant that each trip was 'on' and 'off' several times. Eventually the remaining visits programme was cancelled. There is still no certainty in arranging visits, but where we can do them safely - for example on self-drive outings to Covid proof venues - we shall do so.

Membership: Despite everything our membership has stayed high and Liz Atkins our Membership Secretary has been receiving a steady stream of applications for membership all year. She is standing down this year after six years of service to the Society. She has our grateful thanks for all her hard work and dedication. Two members have come forward to take on the role on a joint basis, and you are being asked to confirm their appointments at this meeting.

Arts Volunteering:

Young Arts - The Society sponsored an excellent drawing workshop for the 5th and 6th formers at The Angmering School with visiting artist Ian Murphy. His work which is a combination of texture and architectural detail has appeared on GCSE and A level exam papers in recent years. The day was fast paced and the quality of work produced was excellent. Planning for a new arts project in Ferring School was curtailed and this will be resumed as circumstances permit.

Heritage Volunteers - The Heritage Volunteers at Arundel castle were very excited to be asked to move on from cleaning the Estates records to boxes of deeds dating from 1200 - 1700. After receiving training from the castle archivist on how to handle these fascinating documents sadly we only had a few weeks working on them before lockdown arrived. These will be waiting for us when we return, but this is unlikely to be before the spring of 2021. The making of Tyvek covers for costumes and shoes at Worthing Museum came to successful conclusion at the beginning of the year

Church Recording - The Church Recording Group completed the recording of St Mary Magdalene in Lyminster and the record is going through the moderation process before being published. There were only a few visits to the new church - St Nicholas in Arundel before the work had to be halted.

I would like to thank all the Society members who volunteer month after month to help at the lectures; serving refreshments, registering and welcoming members and managing the technical side of the meeting. Your contribution is much appreciated. Let's hope we will be able to meet and socialise in person sometime next year.

My best wishes to Miek Bell who takes over as Chair for the 2021 season. Many thanks are due to the committee team who have remained caring, enthusiastic and supportive through these 'interesting times' and have retained a sense of humour throughout. Thank you also to all the members who have kept in touch - your feedback has lifted our spirits in a time when we were missing our monthly get together.

This is a very difficult time for the arts in this country so I hope you will continue to support us and the arts by remaining members of the society.

Treasurer's Report

The unaudited accounts for the year ended 31 March 2020 are presented. The Committee decided to take advantage of the pause in proceedings forced on us by the covid 19 situation to change the accounting year end from 31 March to 31 December to bring us in line with other Art Societies. Approval of the change is sought by resolution at the AGM.

The accounts for the year ended 31 March 2020 show an operating surplus of $\pm 1,651.13$ (2019 $\pm 1,726.16$). The decision has been taken to allow the 2019/20 subscription to run through to the end of the year (31 December 2020).

Accounts will be produced at 31 December 2020 to cover the 21 month period from 1 April 2019 through to 31 December 2020. These accounts will be presented for audit. The accounts thereafter will be prepared annually for the 12 month period 1 January to 31 December.

Reserves at 31 March 2020 were £15,868.57 (31 March 2010 £14,217.44). This comprises the IT Reserve £1,860.44, the Church Recording Reserve £976.72 and the General Reserve £13,031.41 (which represents approximately 9 months cover against normal running costs)

Gift Aid forms will not be sent out this year unless requested by members as the previously signed forms are still valid.
